The nature or purpose of the business entity:

The purpose of this business entity is to engage in any lawful act or activity for which the entity may be organized under the laws of Kansas.

The Socialist Rifle Association Inc. is organized exclusively for advocacy, education, and the promotion of the social welfare within the meaning of 501(c)(4) of the Internal Revenue Code. Upon dissolution, the Socialist Rifle Association Inc. permanently dedicates all remaining funds and assets to such other organizations that are organized exclusively for the promotion of social welfare and that operate to further the common good and general welfare of the community, subject to any

present or future sections of federal, state, or local laws and regulations. Upon dissolution, Kansas law will govern the distribution of the Socialist Rifle Association Inc.'s assets.

This corporation will not have the authority to issue stock. The conditions of the membership are set in the bylaws.
